



**Terms of use of TV Festival 2026 footage**

**CLAUSE 1  
Definitions**

For the purposes of the terms of use herein, the terms set forth hereunder shall have the following meanings:

"Videos" refers to the videos of TV FESTIVAL 2026 which are produced by TOGETHER MEDIA as executive producer on behalf of FRANCE TÉLÉVISIONS ("FTV"), BRUT. and the ASSOCIATION FRANÇAISE DU FESTIVAL INTERNATIONAL DU FILM ("AFFIF") for the period extending from May 12<sup>th</sup> to May 30<sup>th</sup> 2026.

"Site" refers to the interactive electronic service operated by TOGETHER MEDIA under the brand TV Festival.TV, whose URL access is <https://heraw.com/cannes2026>, allowing access to the Service.

"Service" refers to the platform operated by TOGETHER MEDIA by means of which the latter grants to the Users the right to use the Videos for purposes of television broadcast and/or Internet and/or mobile telephone network exploitation, under the terms set forth hereunder and for the period extending from May 12<sup>th</sup> to May 30<sup>th</sup> 2026.

"Users" refers to all and any audiovisual and media professionals and partners of AFFIF whom have an interest in using the Videos.

**CLAUSE 2  
Scope**

Download of Videos by intermediary of the Site is reserved for Users who are cognizant of these Terms of Use in their entirety, and prior to downloading, and have unreservedly accepted such terms.

All and any download imply full and unreserved acceptance of the provisions herein. These Terms of Use may be saved and printed by any visitor to the Site.

**CLAUSE 3  
Service Publisher**

## CLAUSE 4

### Characteristics of the Service

The Service grants access free of charge to Videos arranged with logos which are available for temporary download by means of any computers of the Users that is compatible.

Prior to accessing the Videos for download, and further to acknowledging their acceptance of these Terms of Use, Users shall complete a registration form on the Site which shall require that they enter their personal data. They shall then receive a login and password within 24h, allowing them access to the Videos available for temporary download on the site <https://heraw.com/cannes2026>, (see detailed user guide).

It is strongly recommended to save registration time to use the same email address for the access to the platform and your correspondence with TVF.

## CLAUSE 5

### Terms of Use of Videos

Videos available on the Site regard the following events:

- ✓ The Press conference announcing the Selection
- ✓ All of the films in competition as well as out of competition screenings in the Lumière theatre. With respect to each of these films, footage of the following shall be available to the User:
  - Photocall
  - Press Conference
  - Red carpet
  - Rang I

Videos shall be available from May 12<sup>th</sup> to May 30<sup>th</sup> 2026 in the format and languages specified hereunder:

Rate: 10 Mb/s

Encoding: H.264

Size: 1920x1080

Framerate: 25 Progressive

Audio: L/R stereo - AAC - 192 Kbps - 48Khz

Languages available depending on the events : English, French and original version.

Videos shall be credited FTV / BRUT. / AFFIF

Videos are exclusively intended to be broadcast in the context of news for purposes of public information.

Videos shall be broadcast on a non-commercial basis and may not, under no circumstances, be used for advertising purposes.

Videos shall not be used by brands (excluding AFFIF' partners' brands, FTV or BRUT. in any manner whatsoever and in particular for the purposes of promoting their services or products.

With effect from May 30<sup>th</sup> 2026 at midnight, Videos shall no longer be available free of charge on the Site and may not, under any circumstances whatsoever, be further used by Users.

## **CLAUSE 6**

### **Equipment required to use the Service**

TOGETHER MEDIA, FTV, BRUT. and AFFIF shall under no circumstances, be held liable for any disappearance, loss or deterioration whatsoever including any damage whatsoever that is likely to impair the computer equipment of Users.

Access to the Service is provided in a continuous manner subject to periods of maintenance and repair, server update operations and any possible exceptional interruptions.

## **CLAUSE 7**

### **Termination**

TOGETHER MEDIA, FTV, BRUT. and AFFIF reserve the right to close Users' accounts in the event of:

- ✓ any act that violates the provisions of the French Code of Intellectual Property;
- ✓ any failure by Users to fulfil any of their obligations whatsoever under these Terms of Use.

## **CLAUSE 8**

### **Intellectual Property**

Videos available on the Site are the property of AFFIF, FTV and BRUT. and the "TV Festival" brand is the property of AFFIF; these are subject to French Law governing intellectual property rights.

## **CLAUSE 9**

### **Personal Data of Users**

Access to the Users' personal data shall not imply any kind of transfer by Users to TOGETHER MEDIA of any such data or of any other right whatsoever other than the rights strictly necessary for the enforcement of these Terms of Use. The term data shall have the following meaning: last name, first name, address, type of operations, etc.

TOGETHER MEDIA is prohibited from making any direct or indirect use, including for its own purposes, of such data in any context other than that the one specified in these Terms of Use. TOGETHER MEDIA is prohibited from making any copy, in full or in part, of such data. TOGETHER MEDIA undertakes not to grant and/or make available such data to any third party for any purposes whatsoever, including for marketing purposes. TOGETHER MEDIA shall ensure that personal data are protected from any kind of disclosure.

## **CLAUSE 10**

### **Applicable Law - Language**

These Terms of Use of the Site have been drafted in the French language in accordance with the provisions of French Law TOUBON n° 94-665 dated 4 August 1994. This English translation is being made available to Users of the Site. In the event of any conflict between the French and the English version of these Terms of Use, the French version shall prevail.

These Terms of Use shall be governed by French Law.

Any dispute relating to the use of the Site or to any information contained therein shall be governed by French Law and subject to the exclusive jurisdiction of the French Courts.
